

BE WELL PREPARED FOR FLOODING

A group of residents has recently been in discussions to form an Egham Flood Resilience Group (EFRG). The purpose of EFRG is to be a focal point of information and advice for people living in parts of Egham that are prone to flooding: what to do in advance of and in the event of a flood, so that people and property are well protected.

This note has advice for what you can do to be prepared, in advance of a flood. It is targeted at those streets where flooding has occurred in the past.

1. Firstly, sign up to the Environment Agency's flood alerts and warnings. Then in the event of a flood alert or flood warning being issued for the Egham area the EA will contact you directly. The three levels of Flood Warnings are:

Flood alert: Flooding is possible - be prepared

Flood warning: Flooding is expected - immediate action is required

Severe flood warning: Severe flooding – there is a danger to life

Flood alerts are more common that flood warnings — a **flood warning means the Environment Agency expects flooding of property, and this is the key trigger for a multi-agency response.** Further details on the meaning of the 3 levels can be found here: https://assets.publishing.service.gov.uk/government/uploads/system/uploads/attachment data/file/311020/flood warnings LIT 5215.pdf

- **2. Secondly, write a personal flood plan**. Don't wait for a flood; do this in preparation and keep it in an accessible place. This will prepare you to respond more quickly and more effectively if a flood becomes imminent. A link to the Environment Agency's template for a plan is provided below. - **3. Thirdly, be aware** of the community services available to help during times of flood. Runnymede Borough Council has produced a flooding advice leaflet, which lists the responsibilities of various organisations, and how to contact them: https://www.runnymede.gov.uk/downloads/file/1234/flooding-advice-leaflet
- 4. Finally, water and power losses often occur in areas that have flooded. If you are vulnerable, or could be at particular risk if there's a problem with your water or energy supply, you can pre-register as a priority user with Affinity Water (the water provider in Egham) and with your energy company see the back of your bills for details, and register online or by phone. Pre-registered properties will usually get more help from their suppliers. Pensioners, disabled, chronically sick, long-term medical conditions, hearing, visual or other communication needs, 'vulnerable situations', and having young children under the age of five are all qualifying factors to register.
