Egham Town Residents - Please Join/re-join Today!

Our continuing aim is to help make our community a better place to live. For over 35 years, the Egham Residents Association (ERA) has focused on preserving & improving on the facilities in Egham Town & championing the interests of its residents & visitors.

We recognise that residents can make a difference - shown by our past efforts on projects such as stopping the amendments to the Runnymede electoral ward boundaries, arresting the development of Mrs Caddeys Field, prevention of gravel extraction at Milton Park Farm (for over 10 years), extension of SCC's part-time night lighting proposals &, not forgetting our Association's founding issue in the '80s, keeping Manorcrofts Playing Felds open to the public.

Known issues that are on the ERA Committee agenda for 2019 include:

- ⇒ the **regeneration of Egham Town centre** through the revised Egham Gateway West project at Station Road North plus the opening of the new Egham Leisure Centre;
- ⇒ **maintaining High Street pedestrianisation** through the continued operation of the entry & exit bollards & the enforcement of parking controls;
- ⇒ the never-ending saga of **gravel raising** (at Milton Park Farm & Whitehall Farm);
- fighting Heathrow 3rd runway expansion (on economics, noise, air quality & traffic grounds)
- relationship improvement with the 7,500 students who are in higher education in Egham area, with emphasis on community liaison with Royal Holloway & Strodes;
- the ever-popular Egham Royal Show and Barn Dance, Community Fair, Magna Carta Day, annual coach day trips and other **community events** (see pg4 for current schedule).

Our Committee do this by:

- ⇒ working in liaison with our Town's key influencers e.g. Independent RBC Councillors, SCC Councillors, Chamber of Commerce & community groups e.g. the Egham Town Team & RHUL
- ⇒ supporting election of Independent RBC Councillors & funding their election expenses
- actively seeking to **protect our local environment** e.g. flood planning & opposition to gravel extraction and air & noise pollution (including the impact of possible Heathrow expansion)
- ⇒ watching key **planning issues** and raising concerns with RBC & SCC Planners
- ⇒ organising **public meetings & speakers** on Egham issues e.g. NHS planning & LHR expansion
- ⇒ supporting local groups and charities e.g via the Community Fair etc
- ⇒ **producing quarterly newsletters** (*N.B* <u>only this Winter issue is free to non-members</u>)

HEATHROW 3rd RUNWAY

The High Court will rule on legal challenges against the government's plans to build a third runway at Heathrow Airport in 1Q19. High Court judge Justice Holgate has now ruled that a judicial review will hear all legal challenges simultaneously for 11 days from March 11th. Legal challengers of the government's plans include the boroughs of Hillingdon, Wandsworth, Richmond, Hammersmith & Fulham, and Windsor and Maidenhead, which



are being backed by London mayor and Greenpeace. Heathrow Hub is also challenging the government (as it has proposed a plan for Heathrow expansion that does not involve building a third runway). There are also legal challenges to the third runway from environmental charities Friends of the Earth and Plan B.

Heathrow expansion should be authorised via a Development Consent Order (DCO), a special kind of consent for major infrastructure projects issued by the Planning Inspectorate (PINS). The DCO will contain the consents & powers that Heathrow needs & apparently "places real importance on engagement with residents & stakeholders". Starting with further public consultation, currently scheduled in January-March 2019, the DCO application will then be submitted to PINS, currently expected in 2020.

Ahead of the final decision on Heathrow expansion, RBC, at a Full Council meeting on 6th December, decided to adopt a new, "more pragmatic" position which regretfully acknowledges the Government's decision & attempts to refocus to achieve the best outcome for the Borough from Heathrow. FYI - Egham RBC Councillors were against this change of policy (but were massively outvoted).

Runnymede 2030 Draft Local Plan

RBC LOCAL PLAN EXAMINATION

Initial hearing sessions by the Planning Inspector into the RBC Local Plan took place in late November in Addlestone & will be followed by further, site-specific sessions from February 5th-22nd. The early sessions looked into legal requirements of the plan, the need for

housing & employment land provision, the overall spatial strategy & the Green Belt boundaries.

ERA were present at the hearings & our Vice-Chairman spoke on the fundamentals of the Green Belt, arguing that RBC were too cavalier at eating into the proportion of Green Belt in the Borough (down from 79% to c.75%). This has been caused by the housing target set for Runnymede by central government & RBC didn't make much protest against the target & its consequences?

Moreton Moore, as Chairman of Residents Against Gravel Extraction (RAGE), was also at the hearings &, although mineral extraction is a SCC matter, he pointed out that consequential flooding & air quality issues are within the purview of RBC. Unfortunately the Plan currently ignores the possibility of gravel extraction in the north of Runnymede & makes no reference to its dire consequences for residents.

EGHAM GATEWAY WEST

RBC, in conjunction with their development partner, Places for People, held a public consultation on the new, revised plans for the development complex at Station Road North on 2nd-3rd November. This includes a 3-screen niche cinema (Everyman), 50% residents & 50% student accommodation, ground floor retail but with less massing than previously (but reaching 7 floors in the gateway entrance) & a noticeable parking shortfall - see plan opposite.

Overall, we thought the revised plans were better than the last scheme but there are mixed views on parking issues, height concerns (up to 7 floors), the student block (vis a vis other student developments in the Town) & building design concepts.



Places for People have advised that there were 500 visitors to the consultation & the results of their views would be published as part of the future planning application, which is scheduled for 2H January/early February with a possible construction start in 3Q19 & completion by 2021?



MILTON PARK GRAVEL

In taking us past the 10th anniversary of the original planning application by Hanson's over Milton Park gravel raising, SCC have now deferred their Planning & Regulatory Committee review of plans (which are now going yellow with age) until 20th March 2019 (although it may, as usual, be delayed further)?



N.W.SURREY NHS HEALTH & CARE SERVICES

Working with local partners, NHS North West Surrey Clinical Commissioning Group (NWSCCG) last Autumn launched "The Big Picture" - an opportunity for local people to join an open & honest discussion about the future of care delivered outside of hospital. They held a series of interactive workshops in November & December, which discussed what is meant by the term 'urgent care', public experiences & how to decide what to do when need care urgently & to explore what else healthcare services could do to respond.

In order to update residents on the initial results of this engagement, members of the NWSCCG will be attending our **AGM on 26th February** to discuss their work on shaping the future design of heath & care services in the area outside of hospitals.

EGHAM TOWN CENTRE CONSERVATION AREA APPRAISAL PUBLIC CONSULTATION - AUTUMN 2018



RBC have employed independent consultants (Purcells) to undertake work on reviewing some of the Borough's conservation areas & review the local list of heritage/archaeological assets. The Conservation Area Appraisals will set out what is special about each area & provide guidance & recommendations for their preservation & enhancement. The consultants produced a draft appraisal for Egham Town Centre & made recommendations for the proposed exclusion, & some areas for inclusion, to the existing Conservation Area. The Egham Town CA has not been amended in size since its designation in 1993.

A consultation took place until 2nd January & comments will then be forwarded to their consultants for their consideration before the final Conservation Area is adopted by the RBC later in 2019.

SCC SERVICES CONSULTATIONS (to January 4th)

Surrey County Council (SCC) is facing huge financial pressures due to reducing central government grant despite growing demand for children's and adult care services. SCC have found more than £500mm of savings in areas which have the least impact, but the challenge is getting harder. After talking to their residents and the partners they work with, such as borough and district councils, the voluntary sector and businesses, SCC



needs to take some very difficult decisions. Over the next year they need to save a further £85m which means we will have to make changes to some services. So they launched five consultations (until 4th **January**) as part of its transformation plans on a range of services

These covered Community Recycling Centres (including closing smaller centres - particularly Lyne CRC, which has caused a petition to be raised to try & save it), Concessionary bus travel in Surrey (including removing extra funding for disabled people before 9.30am), Family Resilience and Children's Centres (focusing resources on larger centres), Libraries and Cultural Services (including creating hubs for services) & Special Educational Needs and Disabilities (SEND) (focussing support as early as possible). SCC have organised several "drop-on" sessions around the County during November & December & the results are due to be incorporated in SCC proposals from April 2019.



GREAT BRITISH SPRING CLEAN (March 23rd)

In 2018 over 370,000 #LitterHeroes joined forces - despite the 'Beast from the East' - to collect litter at 13,500 events across the UK, taking a national stand against single-use plastic. In 2019, Keep Britain Tidy are calling on you to help improve the environment on your doorstep & the ERA has registered to participate. including the New Walk museum & arts gallery. The City also houses Abbey Pumping Station, which is Leicester's museum of science and technology, & the adjacent, award-winning National Space Centre.
