Egham Town Residents - Please Join or Renew Today!

Our ongoing aim remains to help make our community a better place to live. For nearly 40 years, the Egham Residents Association (ERA) has focused on preserving & improving the facilities in Egham Town & championing the interests of its residents & visitors.

We know that residents can make a difference - through our past efforts on supporting local shops, organising community events, monitoring local plans (including arresting development of Mrs Caddeys Field & the prevention of gravel extraction at Milton Park Farm (for over 13 years)), consulting with Royal Holloway, lobbying to save our Green Belt, maintaining High Street pedestrianisation, actively supporting Independent councillors (who stand for local residents rather than any political party) &, of course, the ERA's founding issue in the '80s, keeping Manorcrofts Playing Fields open to the public.

Known issues that are on the ERA Committee agenda for 2022 include:

- ⇒ **combatting anti-social behaviour** (including by students) in liaison with the police, RBC & RHUL;
- ⇒ working in liaison with **our Town's key influencers** e.g. Independent RBC Councillors, SCC Councillors, Chamber of Commerce & community groups incl. the Egham Town Team;
- ⇒ **implementation of Egham Town centre improvements** through the Magna Square project at Station Road North & future development of the Precinct ("Gateway East");
- ⇒ maintaining High Street pedestrianisation via better operation of the bollards system;
- ⇒ the never-ending saga of **gravel raising** (at Milton Park Farm & now at Whitehall Farm);
- ⇒ supporting local groups and charities via the Community Fair etc;
- ⇒ the ever-popular Egham Royal Show & Barn Dance, Community Fair, Magna Carta Day, Christmas Fair, annual coach day trips and other **community events Covid-19 permitting**;
- ⇒ watching key **local planning issues** & raising concerns with RBC, SCC planners & our MP;
- ⇒ actively seeking to **protect our local environment** e.g. flood planning & climate change issues;
- ⇒ forming an action group to pursue the ideas suggested in our ERA Residents Survey in 2021;
- ⇒ organising a **photo competition** to promote & show off Egham at its best; &
- ⇒ **producing quarterly newsletters** (*N.B* only this Winter issue is free to non-members).

MAGNA SQUARE

Councillor Isabel Mullens writes: During 2020 we have witnessed new buildings going up on & around Station Road. One of these buildings 'Parish Hall', is now finished and partially occupied. It is named after the building the Parish Room, which previously stood on this site, as recorded in An Egham Scrapbook by Richard Williams, and is remembered by some residents. The stone recording the name of the building above the doorway to the Parish Room is currently stored in the Egham Museum.



The naming of the buildings reflects for the most part the 19th and early 20th century history of our town centre, and we look forward to the opening of Liberty Hall, Corn Merchant House & Gem House within the Magna Square development as the year progresses.

For those who are wondering about the text displayed outside Parish Hall, including the lines: "No unexpected inundations spoil the mower's hopes, nor mock the ploughman's toil"; this is an extract from the poem 'Cooper's Hill', written in 1642 by one-time Egham resident John Denham, buried in Westminster Abbey. The poem refers to the River Thames, 'the most loved of all the Ocean's sons', & is the first example in English of a poem devoted to local description. Look out for more quotes from it as the building work is completed early in the New Year.



GRAVEL RAISING

It came as no surprise that SCC have further delayed their review of the Whitehall Farm & Milton Park Farm planning applications until at least 23rd February 2022 - reaching the 13th year of delays! We suspect that these delays will also be followed by many more......

Further to the Autumn Newsletter, SCC have also now started the consultation process for a new Minerals Plan to replace the old 2011 version. This new, nearly 3yr process started on 15th November, with the commencement of the first phase of the Issues & Options public consultation, **which runs until** 7th **March 2022** (with the new Plan finally issued in Spring 2024). ERA COACH TRIP

After more than 2yrs of cancelling our annual Coach Trip, we have been considering whether to re-establish the event for April 2022? Given that the financial contribution from the trip has not matched the overall cost of arranging it for the last 3 years beforehand, we are currently proposing not to



arrange the trip for next April (given the Covid-19 situation) However, if there is sufficient interest from our members/readers on continuing the event (NB. we need c.40 participants), then we shall re-consider & rebook a Coach Trip (probably to Norwich this time) - *please let the Editor know by early March?*

COVID-19 STATUS

Initially 3 cases of the Omicron coronavirus variant were detected in the UK in late November & new measures were then introduced to slow its spread. Early indicators showed it may be more transmissible than the Delta variant & the vaccines may be less effective against it. To slow the "seeding" of the



virus, anyone who then entered the UK had to take a PCR test by the end of the second day of their arrival and self-isolate until they receive a negative result. Compulsory mask-wearing also returned in England's shops & on public transport from 1st December but will not be required in pubs & restaurants.

Following the exponential rise in Omicron cases, however, the government moved into Plan B in mid-December, with face coverings being mandatory for most indoor public venues, people should work from home "if they can" from 13th December & people will need an NHS Covid Pass - showing their vaccination status or a recent negative lateral flow test - to gain entry to nightclubs, indoor unseated venues with more than 500 people, unseated outdoor venues with more than 4,000 people & any venue with more than 10,000 people. The government is now focussing on ramping up the booster programme to all 18+ by the end of December in a race between the virus & the vaccines - *GET BOOSTED NOW*......

NEIGHBOURHOOD WATCH

Neighbourhood Watch (NHW) is the largest crime prevention voluntary movement in England & Wales and has more than 2.3 million members. In Runnymede, NHW is managed & administered by a Steering Group made up of 7 Area Coordinators and the Surrey Police Designing Out Crime Officer. Between them, the 7 Area Coordinators cover

the 9 Surrey Police crime areas which make up the Borough. There are approximately 120 Watch Schemes in Runnymede which enable us to reach around 7,000 residents. There are also 3 Social Media Watches which have some 6,000 members. In Egham Town, there are currently 11 Watches, & in Egham Hythe & Thorpe there are 12. There are many more roads in these Crime Areas without an active Watch, which means the majority of residents in these Areas are missing out on vital information such as current crime trends and crime prevention advice. Runnymede NHW issue a weekly report covering domestic burglary & car crime. In addition, other agencies issue frequent Alert messages on Anti-Social Behaviour (ASB, inc. the national NHW alert on "No to ASB" circulated on 26th October), Scams, Fraud, Cuckooing, County Lines Drug Dealing & Rural Crime. Best of all - all of this information is available for free!!



ANTI-SOCIAL BEHAVIOUR

From aggressive, noisy or abusive behaviour to neighbourhood disturbances involving drugs or animals, anti-social behaviour (ASB) takes many forms. ASB has become a major issue in Egham, with many of the complaints currently directed at Royal Holloway students - but it is not exclusively a student problem. The effects of ASB are wide-ranging, remedial action is not quick at present & more than 1 agency is involved in tackling it - thus it can be difficult to know who to contact & when?

After discussions with the Police, RBC & Royal Holloway, led by Cllr Sian Williams, we have now come up with an ASB flyer, which summarises what you should do in cases in your area, & this supersedes previous advice on this topic. Copies can be







RUNNYMEDE FLOODING CONFERENCE

Our MP, Dr Ben Spencer, called a first ever Runnymede & Weybridge Flood Conference on 26th November held @TheLit in the High Street. This brought together constituents from Runnymede & Weybridge, resident-led Flood Action Groups, Borough & County Councils, DEFRA,

the Environment Agency, the Local Resilience Forum, the National Flood Forum& other relevant bodies to discuss how to better tackle flooding in a joined-up way for our local communities.
