## RBC ELECTION MAY 5th

With Alan Alderson standing down as a Councillor at the May election (after 20 years of invaluable service for Egham), Sam Jenkins, who currently works at Strode's, is applying for election to his seat. Sam was overwhelmingly endorsed at our AGM on

February 22<sup>nd</sup> as the Runnymede Independent Residents Group (RIRG) candidate for RBC's Egham Town

Sam added: I am an ERA member who lives, works and worships as a practicing Christian in Egham. As Student Engagement Officer at Strode's College, I encourage 6th form students to participate in democratic processes and active citizenship through a number of initiatives e.g. the Egham Community Covid Charter, which was displayed by many High Street businesses during the pandemic & the charter encouraged citizens, students, local traders and businesses alike to adopt Covid-safe practices for the common benefit.

If elected, I will represent a number of causes that are close to ERA members, including campaigning against Heathrow expansion, in favour of gravel protection & increased flood defences, and will fight against excessive night-time noise. I am also keen to make more younger residents aware of RBC projects, with the hope of encouraging more residents to join ERA.

"I am grateful for the hard work that has been put in over decades to make Egham Town an Independent ward, where its residents can be represented by Councillors who care about community interest, not selfinterest. With your vote, I can keep Egham Town independent and protect it for future generations. I am looking forward to the start of the campaign and can't wait to get stuck in".

### MAGNA CARTA DAY (25th June)

Village Fair is now on that date, so the organisers are now working on 25<sup>th</sup> June for the MCD celebrations.

# Reports (22nd February)

#### Chairman

Some 45 members of the Association attended the first physical ERA meeting in 2 years due to the pandemic. the Chairman opened by reviewing a few people that ERA

knew well: Jim Pearcey - our former Chairman was in Frimley Park Hospital suffering from a blood clot on the heart; John Ashmore - who died in December & had been an RBC Councillor for 28 years & the RBC Mayor in 2001-2; and Alan Alderson - who is stepping down as an RBC Councillor this May after 20 years & had been the RBC Mayor in 2016-17.

On the Magna Square development, he noted that it was nearing completion, with Budgens now reopened & an Everyman Cinema due to open in May. Although building height & loss of parking was a concern for the ERA, overall, the development has been for the better for Egham.

The threat of gravel raising still continues, both at Milton Park Farm (MPF) & Whitehall Farm (WF), but both of their applications have been deferred several times (MPF for 13 years & WF for over a year) & are likely to be deferred further.

On students, the continuing misbehaviour of a minority of RHUL students is a growing concern. While the ERA is not anti-student per se, it believes that more emphasis is required on RHUL management efforts, supported by RBC & the Police, & their complaints procedure.

On the Committee, he thanked them for their support during the year & wanted to specifically mention Adrian Skelt, who for his efforts as Secretary & on the Newsletter & EMail Alerts, is really a hero of the ERA, Aneesh Gupta, for his financing efforts (especially on changing our bank accounts), Glenda Thisdell, on looking after membership issues, & Stephen Pollard, who has been leading on RHUL relations. He also wanted to thank the 3 Egham RBC Councillors for their efforts over the year, especially Cllr Alderson after 20 years of invaluable service to the Town.

#### Treasurer

The accounts as @ 31/12/21 were circulated at the meeting & the key points were that subscriptions have kept up during the year, but we had only been able to hold a few fundraising efforts due to the pandemic (& only raised c.£250). Expenditure was greater than income (by c.£250) & ERA now had net reserves of c.£6,300, with over c.£5,500 tied up in accounts at HSBC (which, due to increased bank charges, is in progress for transfer to the Metro Bank - which has been logistically difficult to say the least!).

### RBC Councillors & Candidate Adoption

The Egham Town Independent Councillors on RBC gave their summary annual reports for 2021. Alan Alderson - the "senior" Egham Councillor (first elected in 2002) was absent but the Chairman read out his final report to the AGM. Isabel Mullens - who wanted to focus her report on residents' issues e.g. tree problems around the Town & flooding issues concerning the River Thames Scheme & a proposed Egham Flood Group; RBC committees - where she stood on the Housing & Planning Committees; and other general issues e.g. climate change, where RBC have finally agreed to go net zero by 2030 but the details of the strategy on how to get there is awaited, & on getting more residents to attend RBC meetings. Sian Williams - wanted to thank residents for their voting last year in the delayed election, which led to her being on the RBC committees on Environment & Sustainability, Overview & Scrutiny & Crime & Disorder. She has been focussing on Fairhaven issues of late & on parking concerns in the High Street & its pavements. She had also been instrumental in issuing an Anti-Social Behaviour flyer, in coordination with RBC & the Police, she also volunteered at the Runnymede Foodbank & was a founder of a local group of Boards, Cards & Dice gaming group.

With Alan Alderson standing down as a Councillor, Sam Jenkins, who is a Student Engagement Officer at Strodes, is planning to apply for his seat & has already obtained our Committee's unanimous support to stand. Sam advised that he was already involved in several Town events including the Egham Community Charter & that he lived in the High Street. He saw his main issues being on noise, the 3rd runway at Heathrow, gravel raising, the Green Belt & especially to get more young people involved in Town events. The Chairman likes Sam's enthusiasm & a motion for adoption as our Independent candidate for Egham Town was almost unanimously supported from the floor (with only 1 objection).

#### Guest Speaker

Friends Against Scams is a National Trading Standards Scams Team initiative, which aims to protect and prevent people from becoming victims of scams by empowering people to take a stand against scams. The team was founded in 2012 to tackle the problem of postal, telephone and doorstep scams and identifies and support those who fall victim to them. Kevin McLean, Scam Champion, Buckingham & Surrey Trading Standards, in a slide presentation went through the main postal, telephone, doorstep & online scams & pointed out the benefits of joining the free mail & telephone preference services.

#### CORONAVIRUS STATUS

On 21<sup>st</sup> February the Government announced that a number of COVID-19 restrictions would end in England on 24<sup>th</sup> February. The new 'Living with COVID-19' plan moves beyond the Plan A approach outlined in the Autumn & Winter

plans & takes the next steps in living with the virus. However, the lifting of restrictions does not mean the pandemic is over. COVID-19 continues to spread & people of all ages are at risk of infection.

With infections now rising again (due to Omicron subvariant BA.2), a Spring booster - to be administered 6 months after the previous dose - will be offered to adults aged 75 years +; residents in a care homes; & individuals aged 12 years + who are immunosuppressed or have weakened immune systems.

About 5mm people in the UK will be eligible to book the extra booster jab - with the first 600,000 people being invited from 21<sup>st</sup> March. The Joint Committee on Vaccination & Immunisation has suggested further boosters will be offered to a wider group of people in the Autumn.

All remaining Covid travel restrictions have now been lifted for passengers entering the UK. As of 18<sup>th</sup> March, unvaccinated arrivals will no longer have to take tests & passenger locator forms have been scrapped. However, UK travellers are still advised to check the rules for the countries they are visiting - as many still have restrictions & testing requirements in place (& the NHS COVID Pass will still be available).



#### **GRAVEL RAISING**

The Milton Park Farm (MPF) & Whitehall Farm (WF) planning applications continue to be deferred by SCC (MPF for an unbelievable 13 years & WF for over a year) & are currently scheduled for a 27<sup>th</sup> April review (but are likely to be deferred further).

Progress has been further complicated by SCC's 4-year review of a new Minerals Plan (with the last one being out-of-date from 2011). The initial, background Issues & Options section had a consultation deadline of 7<sup>th</sup> March & the consultation material was framed by several introductory & contextual documents & included 6 main documents outlining the proposed vision, objectives & spatial strategy.

This consultation will inform the preparation of the subsequent 'Preferred Options' public consultation which is set to commence in July 2022 (until October 2022). This will include draft planning policies & proposed sites to be identified, allocated or safeguarded for future minerals management development.

#### RBC CLIMATE CHANGE

RBC will work towards a target of net zero carbon emissions for its own services and operations by 2030, following a unanimous vote at the Full Council meeting on 26<sup>th</sup> January. The decision places RBC alongside other councils in Surrey which have also

Speaking at the meeting, Cllr Marisa Heath, chair of the RBC Environment and Sustainability Committee, said: "This is a vital issue, if we have a target - that will lead to action. We have to be revolutionary; this is the 11<sup>th</sup> hour. We need to expedite this and move forward. RBC already have a number of climate change initiatives but they will bring these initiatives together in a comprehensive strategy".

The Climate Change Strategy will set out what RBC have already accomplished & the overall direction of travel they will take to reduce their emissions. It will explain specific areas that RBC will focus on in the future to bring their emissions down further & how they will work with residents & other organisations to help & encourage them to do the same. Shortly the Council will announce its plans to create a new group where residents & businesses can hear & share ideas about what we can all change & so that everyone can play their part in preventing Climate Change.

#### EGHAM PARLIAMENTARY BOUNDARIES

You will recall that the Boundary Commission for England (BCE) issued its initial proposals last August for revising the Parliamentary constituencies across

the country to make them more even in terms of electorates. The initial BCE proposal moved Egham Town (& Egham Hythe) out of the Weybridge & Runnymede Parliamentary constituency and added them to a new Windsor County one. Despite responses to date, including several stating that the Egham proposal was unworkable on county/community background grounds, the current BCE proposal still has Egham moved into the Windsor constituency.

The BCE launched a secondary public consultation on its initially proposed map of constituencies which closed on 4<sup>th</sup> April. The Commission received over 34,000 responses from the public during its first consultation last year & the original comments are now available to view by area, along with the proposals for constituencies, on the consultation website (bcereviews.org.uk). We repeated our objections by the deadline & the current review will conclude with their formal report and recommendations in June 2023.

### **COUNCIL TAX** 2022/23

The overall Council Tax Bill is made up of three elements:

RBC Services, SCC Services, which includes, adults and children's services, schools and highways, & funding of Surrey Police.

While Runnymede has asked people in Band D to pay £4.96 more per year to fund its services (2.9% increase), SCC has increased its figure by £77.10 (4.99% increase) and Surrey's Police and Crime Commissioner has increased her requirement to fund the force by £10 per year (3.5% increase).

The Government is this year allowing borough councils to raise council tax by a maximum of £5 or two per cent, whichever is higher.

This means that the overall increase for people living in band D homes in Runnymede will be £92.27. The total bill for a band D home will be £2,101.51 for the 2022-2023 financial year, compared with £2009.24 for the previous year.

Despite the increase, Runnymede residents will pay the lowest Council Tax in Surrey for its Services.

The breakdown by Council Tax Band is as follows:

Band A - £1,401.01	Band B - £1,634.51
Band C - £1,868.01	Band D - £2,101.51
Band E - £2,558.51	Band F - £3,035.51
Band G - £3,502.52	Band H - £4,203.02

The Government have announced a £150 council tax rebate for Band A-D properties & the payment will not appear on the Council Tax bill. If you pay your Council Tax by Direct Debit, the payment will go directly into your bank. If you do not pay by Direct Debit, RBC will provide details on how to claim this payment once they have arrangements in place. This is unlikely to be before the end of April.

#### ERA COACH TRIP

After the advert in the Winter Newsletter, only 5 residents have contacted us about a possible Coach Trip this year. There has thus been insufficient interest to justify a booking & we will not unfortunately be arranging a trip in April.
